The Year in Review

Dear Friends:

It's hard to believe that one year has passed since I joined the staff of New Hope in August of 2014. New Hope's 36th year saw many changes and challenges, and I'm proud to report that we have emerged stronger and more unified as an agency. But before we turn the page on fiscal year 2015, I'd like to take a moment to share with you some insights and highlights from the year past.

In fiscal year 2015, four of nine New Hope programs saw a dramatic increase in services provided.

Our Worcester-based MJ Leadenham Center saw a 15% increase in family visitation appointments. Community-based Counseling and Advocacy Services — which are offered throughout New Hope's catchment area — saw increases of 18% and 33%, respectively. And our RESPECT Batterer Intervention program enrolled 22% more first-time participants year over last.

So, what drove the increased demand? In part, the increases were the result of the new domestic violence law (Chapter 260) enacted by the state legislature in 2014. Additionally, increased community training led to improved identification of victims in need of New Hope services. It's also important to note the role of public discourse, specifically the discussions around domestic violence, child abuse and campus sexual assault within the context of college and professional sports. When victims realize they are not alone, they often find the courage to come forward and seek assistance.

With that I want to thank YOU for your continued support of and engagement with New Hope. Each day on the job reminds me that it does truly take a village to move closer to our mission of *ending domestic and sexual violence in our communities*. As we continue our work I ask you to remember and share the idea that "no one person can do everything, but every person can do something!"

24-hour Confidential Hotline

The New Hope Hotline — our flagship program launched in 1979 — provides round-the-clock crisis response, safety planning and referrals to victims (and concerned family/friends) by trained professionals.

1,602 callers assisted in FY 2015



Emergency Residential Shelter

New Hope operates two confidential residential shelters in Massachusetts, providing a safe haven to survivors of violence — and their dependents — who are fleeing abuse. The shelter is far more than a building; it is a comprehensive program consisting of case management services, safety-planning, counseling and skill building aimed at helping clients heal from the after-effects of abuse.

Counseling & Advocacy

New Hope's Counseling & Advocacy program provides up to 12 free individual sessions — and unlimited group counseling — to adult and child survivors of domestic/sexual violence. New Hope's mental health professionals utilize a trauma-informed method of care with a focus on personal safety and the development of healthy coping skills.

980 counseling sessions and 206 advocacy sessions provided in FY 2015



Sexual Assault Nurse Examiner (SANE) Program

New Hope provides 24-hour on-call sexual assault medical advocacy to any individual who presents as a victim of violence at Morton (Taunton) and Sturdy Memorial (Attleboro) hospitals.

Housing Stabilization Fund

The issues of homelessness and domestic violence are deeply interconnected. In an effort to help prevent instances of homelessness at the hands of domestic violence-related relocation, New Hope offers its Housing Stabilization Fund. Anyone who has experienced domestic/sexual violence within the past year and lives in New Hope's catchment area is eligible to apply for up to \$1,000 to pay for rent, past-due utilities, relocation fees and other expenses to remain safe and stable.

New Start Transitional Living Program*

New Start TLP is an 18 month program available to families who have progressed through the initial high-risk stages of recovery. New Start TLP helps survivors continue on their path to independence by providing subsidized housing and intensive casework.

9 adults and 17 children assisted in FY 2015

*In fiscal year 2016 New Hope transitioned this program to Catholic Social Services.



SAFEPLAN Court Advocacy

New Hope employs state-certified SAFEPLAN advocates in eight courts across Massachusetts who offer safety planning, community referrals and assistance in obtaining legal protections from their abusers.

RESPECT Certified Batterer Intervention

RESPECT engages perpetrators of domestic and sexual violence in 40 weekly group sessions. The curriculum holds perpetrators accountable for their behavior in order to prevent violence in their current & future relationships.

Outreach and Education

Our Community Outreach and Education staff offers seven targeted training programs to schools and the community at large. Topics include: child assault prevention, bullying, harassment, teen dating violence, healthy relationships and sexual violence prevention.



3,675 participated in a New Hope education program in FY 2015

Visitation Center

New Hope's MJ Leadenham Center in Worcester provides critical services to families impacted by domestic and/or sexual violence. The Center provides three forms of parental assistance: Supervised Visitation, Monitored Visitation and "Safe Exchange."






Civilian Police Advocate






